The key insight from science is that being risky is not only a matter of individual inclination – but there can be reasons for "bad' behaviour". Two and a half decades of research on drugs harm reduction has led to sophisticated methods to assess risks and epidemics to encourage evidence informed policy. There is also a large evidence-base on the effectiveness of harm reduction interventions in various health related sectors. The new science of risk behaviour shows that drug users will change their behaviour to protect their own health and that of others. He was Director of Communications for DrugScope, writing books and articles, giving conference presentations, academic lectures and media interviews. Since 2015, he has carried on working in the field of harm reduction as applied to the public health imperative to encourage smokers to switch away from cigarettes.
	The latest GSTHR report offers an overview of key issues in Tobacco harm reduction and the right to health. Its public health potential and relationship with human rights gives insight into the developments over the last two years of tobacco harm reduction and use, availability and regulatory responses to safer nicotine products around the world.
